



THE 2009 PRESIDENTIAL TOUR

SUPPLEMENTARY REGULATIONS

HRA TOURING CHAMPIONSHIP RD. 4

SUNDAY 6th DECEMBER, 2009

1. THE EVENT.

The event shall be known as the “2009 Presidential Tour”, hereafter referred to as “The Event” and will be run as a Multiclub Touring Assembly over public roads during daylight hours on Sunday 6th December 2009.

The event is a Round 4 of the 2009 Historic Rally Association (HRA) Touring Championship.

2. AUTHORITY.

2.1. The Event will be conducted under the provision of the International Sporting Code of the F.I.A; the National Competition Rules [NCR] of the Confederation of Australian Motor Sport Ltd [CAMS]; these Supplementary Regulations and any Further Regulations/Instructions and Route Instructions, which may be issued.

2.2. The CAMS Permit Number 309/0612/02 will be on display at the start.

3. SCHEDULE OF DATES.

1. Entries Open: Upon publication of these Supplementary Regulations.
2. Entries Close. Wednesday 2nd December at 8.00pm
3. Start of Event. Sunday 6th December 2009 at 11.00am

5. CREW ELIGIBILITY.

5.1 The Competitor and at least one crew member must hold a CAMS level 2NS Licence or superior and be a current financial member of and hold a club membership card issued by a CAMS affiliated car club.

(Please Note: "competitor" is defined as the legal owner of the car.)

5.2 The driver of the vehicle must hold a current and valid civil drivers licence.

5.3 To be eligible for points towards the HRA Touring Championship a crew member must be a current financial member of the HRA.

6. VEHICLE ELIGIBILITY & SCRUTINY.

6.1 All competing vehicles must be registered or have a permit allowing the vehicle to be driven on public roads in the State of Victoria.

6.2 All vehicles may be checked for general roadworthiness and must be equipped with a seatbelt for every vehicle occupant. If in the opinion of officials at the start, a vehicle is not safe to compete, permission will not be granted for that entry to start.

6.3 The following documents are required to be produced when booking in at the start control: -

- Current CAMS Level 2NS (or superior) licences of the competitor and at least one crew member.
- Proof of current car club membership for the competitor and at least one crew member.
- Current registration certificate or permit for the competing vehicle.
- Current drivers licence for all those likely to be driving during the event.

7. ENTRIES.

7.1 The entry fee for the Event shall be \$60.00.

7.2 CAMS Personal Insurance is provided for all current financial members of a club affiliated with CAMS in Victoria.

7.3 Cheques or Money Orders should be made payable to the "Historic Rally Association Inc." not HRA.

Electronic Funds Transfer.

If you wish to pay your entry fee by EFT you MUST print & attach a copy of the transaction receipt to the Entry Form.

In the payment description field, please use the three letter event code "TPT" followed by the Competitors Surname: eg: TPT Officer.

7.4 Entries must be on the official entry form and must be complete in every detail.

7.5 The field for the Event shall be limited to fifty [50] cars to be determined by order of receipt of entry. HRA members who are contesting the HRA Touring Championship are encouraged to enter early as no guarantee can be given that the field will not be filled. No field extension is possible.

8. STARTING ORDER.

8.1 Vehicles will start in order of entry, the first car departing at 11.00am with subsequent cars departing at 1 minute intervals.

9. EVENT RUNNING DETAILS

9.1 The Event will start at BP Northpoint, Corner Scanlon Drive & Cooper Street, Epping

The finish is at the Grand Hotel, Yarra Glen.

9.2 Book-in will be available from 10.00 hrs.

9.3 Route Instructions will be available to competitors after Book-In.

9.4 The total distance & time allowed for the event will be advised in Further Instructions. Crews shall be required to complete the course within a maximum of five hours in order to be classed as a finisher.

The Finish Control for the event will close in 5-minute increments up to a maximum time of 60 minutes. After which time Competitors will be deemed to have missed the Control.

Actual distance for the event will be issued in Route Instructions.

9.5 First car is expected to finish at around 4.00pm.

9.6 There will be no crew briefing. Crews will be issued with Further Instructions and their start time on receipt of the completed Entry Form.

9.7 All Civil road regulations must be obeyed throughout the Event.

10. OFFICIAL MAPS

10.1 The official maps for the event will be supplied by the organisers
No other maps (including street directories) are to be carried in the vehicle. GPS devices and mobile phones with GPS devices are not permitted.

11. CONTROLS

11.1 An “M” board will mark Major Controls; manned Passage Controls will be marked by a “P” board.

At a manned passage you are required to stop each time such a location is entered and the official will make a notation on your road card.

11.2 Information may be required to be noted at specified via's or at any location along the route that the director may require a crew to visit.

At via points in the is event you will find any, or some, of the following;

- Nothing
- Information boards
- Redirection boards
- Manned Passage
- Prescribed Observation(s), e.g. signpost

Note: - Information at via's will not be preceded by an “O” board and may not be facing direction of entry. i.e. Information Boards may be located parallel to the road/fence boundary.

11.3 CARRIAGE AND USE OF A DIGITAL CAMERA IS ESSENTIAL.

YOU MAY BE REQUIRED TO PROVIDE PHOTOGRAPHIC PROOF OF PRESCRIBED OBSERVATIONS USING A DIGITAL CAMERA.

FURTHER INFORMATION ABOUT DIGITAL CAMERAS WILL BE ISSUED IN FURTHER INSTRUCTIONS.

11.4 Observers may be on course to note any infringements of traffic laws.

11.5 Samples of all boards to be used will be on display at the start.

12. SCORING & PENALTIES.

Scoring will be as follows: -

Incorrect or missing Information.	10 points per instance.
Recording of Incorrect Information	10 points per instance.
Manned Passage – wrong direction	5 points per instance.
Manned Passage – missed	10 points per instance.
Entering any Control from a Wrong Direction	5 points per instance.
Entering “Out of Bounds” area	10 points per instance.
Major Control - Late	10 points per every 5-minute interval over allowed time, up to a maximum of 120 pts.

Crews arriving after the allocated time will be deemed to have missed the control.

Detected breaches of Traffic Regulations. 20 points per instance.

13. AWARDS.

1st Outright Crew	
1st Expert Crew	HRA A Grade
1st Intermediate Crew	HRA B Grade
1st Novice Crew *	HRA C Grade
1st Non HRA Crew*	

- To be eligible for Novice Award crews must not be experienced in navigational type events.
 - The Clerk of Course will decide eligibility for all awards referring to the HRA Grading List.
 - 2009 HRA Grading List can be found on www.hra.org.au
 - Multiple prizes will not be awarded.
 - Further trophies may be awarded; details will be issued in Further Instructions.
- The Clerk of Course may grade crews at her discretion

14. JUDGES OF FACT.

All control officials and observers designated by the Clerk of Course are deemed to be Judges of Fact of the following: -

- Time and direction of entry & exit at their control.
- Detected breaches of Traffic Regulations.
- Roadworthiness of Vehicles.

15. POSTPONEMENT, ABANDONMENT, CANCELLATION.

In accordance with NCR 59, the Organising Committee reserves the right to postpone, abandon or cancel the event if in their opinion the entries are insufficient or by “Force Majeure”.

16. ALCOHOL

Participants are reminded that the consumption of alcohol is forbidden in accordance with the CAMS Anti-Doping Policy and NCR145a.

17. CONTRACTORS.

No paid or unpaid Contractors are used in this Event.

18. OCCUPATIONAL HEALTH & SAFETY (OH&S) POLICY.

18.1 The OH&S Policy for this Event is the CAMS OH&S Policy which is available for viewing and is available as a downloaded document from the CAMS website: www.cams.com.au

18.2 Due to the moving nature of The Event, the OH&S Policy will not be viewable during the Event. It is a requirement of Competitors that prior to The Event Start, all competitors and officials make themselves aware of CAMS OH&S requirements.

18.3 A Medical Response Plan is not applicable, all competitors and officials are advised that Ambulance Cover is advisable. In the event of an Emergency requiring medical response, the use of Mobile Phones is encouraged. Emergency contact numbers will be made available in Further Instructions.

18.4 Given the moving nature of The Event, it is not practicable to hold a separate briefing/site induction prior to the Start. Any changes/additions to the Supplementary Regulations will be advised in Further Regulations.

18.5 By Signing the Entry Form the Crew acknowledges they have read and understood the CAMS OH&S Policy.

In exchange for being able to attend or participate in the event (including entering the event), I agree:
